## Notice of June 9, 2025 Board of Retirement Election

This June, SamCERA will hold an election for its Retired Member board seat and its Alternate Retired Member board seat.

amCERA's Board of Retirement is its governing body, responsible for pension administration and the investment of trust fund assets. The Board is comprised of nine members and two alternates. SamCERA's retired members elect one regular Board member and one alternate Board member.

Retired members who are interested in serving on the Board of Retirement are encouraged to run for election by filing a declaration of candidacy with the Elections Officer. **Declarations of Candidacy must be filed in person with the Registration & Elections Division no later than 5:00 p.m. on Monday, April 28. 2025.**

## 2025 Cost-Of-Living Adjustment Increase

he Board of Retirement approved cost-of-living adjustments (COLA) for most retirees and beneficiaries that will begin with the April 2025 retirement benefit payment.

The COLA applies to eligibile retirees and beneficiaries who retire on or before April 1, 2025, and the amount of the COLA may vary depending on the retirement plan. All COLAs will be paid beginning with the April 30, 2025 benefit payment.

Retiree or Beneficiary's Plan Type	Date of Retirement	2025 COLA %	COLA BANK %
Plan 1 - General and Safety	On or before 4/1/2025	3.0%	n/a
Plan 1 - Probation	On or before 4/1/2025	3.0%	n/a
Plan 2 - All Members	On or before 4/1/2025	3.0%	n/a
Plan 3	n/a	n/a	n/a
Plan 4, 5, 6, 7 - All Members	On or before 4/1/2025	2.0%	n/a

The COLA for Plan 1 General, Safety, and Probation members is 3.0%. The COLA for Plan 2 members is 3.0%, and the COLA for Plans 4, 5, 6 and 7 is 2.0%. Plan 3 members do not receive a cost-of-living increase.

**Retired Member and Alternate Retired Member Eligibility:** Candidates must be retired SamCERA members and may only nominate themselves to one position, either the Retired Member seat or the Alternate Retired Member seat by filing a Declaration of Candidacy with the Elections Officer.

**Member Terms:** The Retired member and the Alternate Retired member shall serve from July 1, 2025 – June 30, 2028.

Manage your pension account with the easy to use MySamCERA member portal.


#### **Getting started**

#### **Easy, Online Access To Your Benefit Statements**

Monthly benefit statements are available to view and print online at your convenience. These statements provide the amount deposited in your account each month, along with any itemized deductions. You will receive an email notification when a new statement is available on the MySamCERA member portal. Once logged in, click on the **Your Plan**, and then click on **Upload/View Documents** to view and print your statements.

#### **COMING SOON** - Enhanced Security for Your MySamCERA Account!

We're strengthening the security of your MySamCERA account with two important updates. First, stronger password requirements will soon be in place. If you're resetting your password or creating a new account, your password will need to be between 16-64 characters and include at least 1 numeric character, 1 uppercase letter, and 1 lowercase letter.

Additionally, we'll be introducing Multi-Factor Authentication (MFA) to provide an extra layer of protection to your account. This means you may need to verify your identity with a code sent to your phone or email when logging in. To ensure a smooth experience, please take a moment to update your phone number and email address in MySamCERA so you can receive verification codes without any issues. **Did you know?** A pension verification letter confirms your retirement benefits, such as your monthly benefit amount and retirement status. Some members may need this for loan applications, lease agreements, and other situations that require income verification.

Requesting a pension verification letter is easier than ever in the MySamCERA member portal and mobile app. After logging in, click on "Your Plan" in the navigation menu, then click on "Pension Verification."

To request a new pension income verification letter, click on the "Request Pension Verification" button on the next screen. You can also view and download past pension income verification letters on this screen.

# Your 2024 Tax Forms Are Available On MySamCERA

1099-R Annual Tax Reporting Statements were mailed in January and are available online now.

1099-R tax forms have been mailed to the addresses we have on record for retirees and beneficiaries who receive a taxable benefit. This form contains essential tax information including reportable income, taxable income, federal taxes withheld, and California state taxes withheld, if applicable.

#### Access Your 1099-R Online

Follow these steps to view and print your 1099-R online:

Log in to MySamCERA on a computer or laptop. Click on Your Plan on the left navigation menu. Select 1099R Tax Information. Select a 1099R from the list to view and print.

#### **Keep your Address Up to Date!**

It's important that we have your current address on file for you to receive important information from us, such as your 1099-R. You can update your contact information by completing an address change form available on the SamCERA website at www.samcera.org/forms.

# Update Your Tax Withholdings Anytime

You can change your tax withholding election anytime throughout the year by completing a new Tax Withholding form (available at www.samcera.org/forms).

Requests to increase or decrease your withholding that are received by the 15th of the month are effective in that same month. Requests received after the 15th become effective the following month.
