REMINDER:

Rules for Returning to Work After Retirement

It's important to keep these rules in mind if you are receiving a service retirement allowance from SamCERA and are considering returning to work for a SamCERA-covered employer:

- Regardless of your age, retired general members are not eligible to return to work as extra-help or under a contract for a SamCERA employer for a period of 180 days following retirement, except under special circumstances.
- Retired safety employees under the age of 53 cannot return to work within 90 days of retirement, except under special circumstances.
- Post retirement service is limited to 960 hours per fiscal year (July 1-June 30)

Before you start working again, make sure that you are aware of all the requirements to avoid having your benefit suspended. For more information, email samcera@samcera.org.

Keep Your Information Up-To-Date

It's a good idea to check the contact information on your SamCERA account at least once a year. It's also important that we have your current address on file so you can receive important information from us, such as your 1099-R.

Stay Secure:

Essential Tips for Your Retirement Account

At SamCERA, your security is our top priority. To help you protect your personal information and maintain the safety of your account, we're sharing some essential tips. Taking proactive steps can significantly enhance your security and ensure your peace of mind.

Monitor Your Account Regularly

It's important to regularly check your account for any unusual activity or transactions. If you notice anything out of the ordinary, please report it to us immediately. Early detection can help address issues quickly and minimize potential risks.

Update Your Password

If you haven't changed your password recently, now is the perfect time to do so! Our new password requirements are designed to strengthen your account security. Please ensure your new password meets the following criteria:

- Minimum of 16 characters
- Maximum of 64 characters
- At least 1 numeric character
- At least 1 uppercase letter
- At least 1 lowercase letter

Creating a strong, unique password that you don't use for other accounts adds an extra layer of security to your information.

A great way to create longer, more secure passwords is by using passphrases—simple, memorable phrases like "SunnyDaysAhead2024!"

Stay Informed

To ensure you receive important information and updates from us, we recommend adding our email address samcera@samcera.org to your address book. This helps prevent our messages from being filtered into your spam or junk folder, so you never miss important communications.

By following these guidelines, you can help ensure your account remains secure and your personal information is protected. Thank you for being a valued member of the SamCERA community!

Additional Security Tips

- 1. Use Unique Passwords: Always use different passwords for different accounts to keep them safe.
- 2. Enable Security Questions: Set up security questions that are hard for others to guess but easy for you to remember.
- 3. Keep Software Updated: Regularly update your devices and applications, including antivirus software.
- 4. Be Wary of Phishing Attempts: Be cautious of unsolicited emails. Avoid clicking on links or opening attachments from unknown sources.
- 5. Use Secure Wi-Fi Connections: Avoid logging into your account on public Wi-Fi networks.
- 6. Log Out After Use: Always log out of your accounts, especially when using shared or public computers.
- 7. Review Statements: Regularly review your benefit and financial statements for any unauthorized activity.
- 8. Report Suspicious Activity: If you notice anything unusual, report it immediately.
- 9. Data Privacy: Keep personal information private and only share it when necessary.
